IMPORTANT TESTING INFORMATION AND REMINDERS FOR COMPUTER-BASED TESTING

Dear FTCE/FELE Examinee:

Please review the following important information and reminders about test day preparation, score reports, the 31-day rule, signed statement of assurances, and important contact information.

TEST DAY PREPARATION

Reviewing Your Admission Ticket: Your admission ticket for a Florida Teacher Certification Examination (FTCE) or a Florida Educational Leadership Examination (FELE) is enclosed. It is very important that you read your admission ticket and make sure that all of the information is accurate before reporting to the site on the day of the test. Depending on your test selection, you may receive two separate tickets. If you do, review the information on both tickets and bring them both to the test site.

You have been assigned to the test site printed on your admission ticket. You may test only at the site printed on your admission ticket. No other site will be authorized to admit you for testing.

Your admission ticket lists your appointment time. **Please report to the test center 30 minutes before your scheduled appointment time.** Administration preparations, including verifying identification, seating examinees, and recording general information must take place before the actual testing begins. The tests vary in length. See the admission ticket for details.

What to Bring: You must bring your admission ticket and two valid and unexpired forms of identification that are printed in English. The first identification must be government-issued and must have a clear photo **and** your signature, such as a driver's license, state-issued identification card, United States military ID with signature, or passport. The second identification, which you may be asked to produce, must have either a photo or a signature, such as a Social Security card, work ID, or student ID card. If you do not have proper identification, you will not be permitted to test.

If you are taking a test that requires using a calculator, the test site will provide one for you; do not bring your own. You may wish to bring a sweater or jacket to ensure your comfort.

You may not bring any materials into the testing room except those specifically indicated by the test administrator. Your personal belongings will be stored securely. Examples of personal belongings include bags (such as purses, backpacks, briefcases, and packages), hats, outerware, computers, books, written materials, cellular phones, pagers, and good luck charms. You will not be admitted late. If a prohibited aid is discovered during the test, the violation will be reported to the Department of Education and your scores may be invalidated. For a complete list of prohibited aids, see the enclosed letter titled "Important Information about Cheating Behaviors and Test Score Invalidation."

Test Information Guides: While most of the FTCE and FELE examinations consist of multiple-choice test items, a few tests have special features such as essays, tape-recorded speaking portions, and videotaped portions. Descriptions of such special features may be found in the individual FTCE and FELE test information guides (\$5.62 each), which may be ordered by mail or downloaded online at www.fl.nesinc.com. TEST SCORES AND SCORE REPORTS

A copy of your scores from this test administration will be submitted electronically to the Bureau of Educator Certification at the Florida Department of Education in Tallahassee. It is your responsibility to communicate with the Bureau concerning the issuance of your certificate.

You will be sent two original, identical score reports approximately two weeks after the test. A copy of your score report will be sent to the college or school district of your choice **IF** you requested it when you registered. If you wish to share your scores with anyone else, you must provide the copies yourself.

Please note: Your test scores will be invalidated if you retake the same test sooner than the 31st calendar day after the previous administration, or sooner than the 31st calendar day after attending a score verification session.

SIGNED STATEMENT OF ASSURANCES

The registration bulletin includes several statements of assurances, which are repeated below for your reference. By registering online, you agreed to be bound by these terms.

Statements of Assurances for the Florida Teacher Certification Examinations and Florida Educational Leadership Examination

I understand that the Florida Department of Education reserves the right to refuse admission to me if I do not have the proper identification (valid admission ticket and two positive identification forms specified on the admission ticket). I understand that if I arrive at the examination site after the examination has actually begun, I will not be admitted until the admission time for the next subtest, if applicable.

I understand that examinees cannot bring any electronic communication or recording device, including a cellular phone, beeper, personal digital assistant (PDA) such as a Palm Pilot, or listening device such as a compact disc or tape player, into the testing room or break areas around the testing room.

I understand that all of the examination materials are the sole property of the Florida Department of Education and that I am not permitted to take any of the examination materials from the examination center or to reproduce the materials in whole or part by any method. If I do anything prohibited by this paragraph, my examination performance will be voided.

I understand that during the examination I will not be permitted to use written notes, make written notes of the content of the examination, or communicate with other examinees in any way. I understand that any essay I write must be an original essay composed and organized by me on the test day, in direct and complete response to a topic. I understand that I am not permitted to give assistance to or receive assistance from other examinees. I must follow the instructions of the test administration personnel, and I must be the person whose name appears on the sign-in roster for this test. If I do anything prohibited by this paragraph, my examination results will be voided.

I authorize the team of proctors at my assigned examination center to serve as my agent in maintaining a secure and proper examination administration. I agree that, in this capacity, the proctors may relocate me before and during the examination.

I understand that some developmental items may be included in the examination but will not be counted in my final score. By registering, I acknowledge that I have read the statements above, understand them, and agree to be bound by these terms.
